

Terms & Conditions (the “**Terms**”) for Champion Call Campaign.

Please note: Fan Tokens are not and shall not be construed as investment or financial products; they are a form of crypto-assets. Be aware that: (a) their value is volatile and may fluctuate widely (both up and down); (b) in many jurisdictions these types of assets are unregulated, but take into account that regulations for cryptoassets vary widely from place to place, and those may change, possibly affecting your legal rights or obligations; and (c) you may be liable for taxes on profits. Trading these assets entails significant risks, potentially resulting in a total loss of funds, and is not suitable for those under 18 or those without proper understanding. Consult a qualified advisor if necessary, and trade at your own risk. Socios disclaims liability for any related loss or damage.

Campaign:

1. This Campaign is called “**Champion Call**” (the “**Campaign**”).
2. The Promoter of the Campaign is **Socios Europe Services Limited**, a company incorporated under the Laws of Malta (“**Socios**” or the “**Promoter**”);
3. The provider of the prizes can be the Promoter or any of the Promoter’s affiliates.

Description of the Campaign

1. The Campaign gives eligible Participants the opportunity to receive provisional entries in a prize draw related to eligible Fan Token purchases during the Campaign Period, backing the team they believe will win the 2026 World Championship Final. Following the official end of the 2026 World Championship Final, only provision prize draw entries associated with the Fan Token of the winning team will become valid entries and be entered into the prize draw. Fan Tokens remain yours at all times, regardless of result. Participation will not result in any loss of Fan Tokens whatsoever.

Eligibility and Participation

1. The Campaign is open to participants who satisfy the conditions set out under these Terms (“**Participant(s)**”/“**You**”/“**Your**”/“**Yourself**”).
2. The Campaign begins on 16 July 2026 at 15:00 CEST (the “**Opening Date**”) and ends on 19 July 2026 at 20:59 CEST (the “**Entry Cut-Off**”). The period between the Opening Date and the Entry Cut-Off shall be referred to as the “**Campaign Period**”.
3. Only qualifying purchases of \$SPAIN and \$ARG Fan Tokens completed through the decentralised exchange that can be accessed through the Socios.com platform interface, between the Campaign Start and the Entry Cut-Off, may generate Provisional Entries (“**Provisional Entries**”). Fan Tokens remain yours at all times, regardless of result. Participation will not result in any loss of Fan Tokens whatsoever.

4. Anyone who attempts to participate following the Entry Cut-Off will not be eligible to participate and will not be considered, with the exception of eligible free postal entries which may be received by no later than 24 July 2026 10:00 CEST, subject to the further details outlined below.
5. Upon the Entry Cut-Off, Socios will determine the number of Provisional Entries generated by each eligible Participant.
6. Eligible Fan Tokens that generated Provisional Entries must remain held in the Participant's Socios.com wallet from the Entry-Cut Off until the official end of the 2026 World Championship Final match, including any extra time and penalties.
7. To participate, you **MUST**:
 1. Be aged eighteen (18) or over.
 2. Accept these Terms (participating in the Campaign will be understood as your implied acceptance of these Terms).
 3. Follow the instructions outlined in these Terms.
 4. Have an active Socios.com account in good standing and hold a Socios.com wallet.
 5. Be in full compliance with the Socios.com Global Terms of Use.
 6. Be a resident in a jurisdiction where participation in the Campaign and prize draw is legally permitted and not restricted.
 7. Not otherwise be excluded under applicable law, the Global Terms of Use or these Terms.
 8. Comply with any additional entry requirements or conditions specified by the Promoter.
1. **Prohibited Jurisdictions** are any of the following jurisdictions: Afghanistan, Burundi, Central African Republic, Cuba, Democratic Republic of Congo, Guinea-Bissau, Iran, Iraq, Kosovo, Lebanon, Libya, Myanmar, North Korea, Russia, Somalia, South Sudan, Sudan, Syria, Turkey, United States of America, Venezuela, Yemen, Zimbabwe. This list may be amended at any time at Promoters' sole discretion.
2. **The following persons ARE NOT ELIGIBLE to participate in the Campaign:**
 1. **Employees of the Promoter, its affiliates, subsidiaries, advertising agencies, or any other company involved in the design, production, execution, or distribution of the Campaign, as well as the immediate family members (spouse, parents, siblings, and children) of such employees.**
 2. **Residents of Türkiye and the United Kingdom and of any of the Prohibited Jurisdictions listed above.**
 3. **Additional geographic restrictions may apply as deemed necessary by Socios.**
 1. The eligible Fan Tokens for the Campaign will be the Spain Fan Token (\$SPAIN) and the Argentina Fan Token (\$ARG).
 2. Only: (i) \$SPAIN and/or \$ARG Fan Tokens; (ii) purchased through the decentralised exchange that can be accessed through the Socios.com platform interface; (iii) during the Campaign Period; are eligible for this Campaign. Fan Tokens transferred into Your Socios.com wallet from an external wallet are excluded and will not generate Provisional Entries, nor will those Fan Tokens purchased or held before the Opening Date.
 3. Each whole, undivided one (1) eligible \$SPAIN or \$ARG Fan Token will count as one (1) Provisional Entry for the potential prize draw associated with the corresponding team. For the avoidance of doubt, fractional Fan Tokens will not count toward or accumulate to

form an entry, and any fractional holdings will be rounded down to the nearest whole number. Solely by way of example: 1 eligible Fan Token = 1 Provisional Entry for the potential prize draw associated with the corresponding team; 10 eligible Fan Tokens = 10 Provisional Entries for the prize draw associated with the corresponding team; 100 eligible Fan Tokens = 100 Provisional Entries for the prize draw associated with the corresponding team; 0.12 eligible Fan Token = 0 Provisional Entries; 1.9 eligible Fan Tokens = 1 Provisional Entry for the prize draw associated with the corresponding team.

4. Following the official end of the final match, only Provisional Entries associated with the Fan Token of the winning team will become valid prize draw entries.

Free Method of Entry

1. **An eligible Participant may obtain one (1) free Provisional Entry by sending a written request by registered post or courier (to ensure record of delivery) to Socios, Level 6, Wembley Business Centre, 179, Rue D'Argens, Msida, Malta.**
2. **Such entries must be received at the address above by no later than 24 July 2026 at 10:00 CEST to be eligible for the prize draw.**
3. **The written request must:**
 1. **Clearly state that You wish to enter the "Champion Call" prize draw.**
 2. **Indicate which team you would like to back and therefore which prize draw You would like to receive one (1) free Provisional Entry to i.e. the prize draw associated with either the team of Spain or the team of Argentina.**
 3. **Include Your details, most notably Your Socios.com wallet address.**
 4. **Comply with any additional submission requirements specified by the Promoter.**
1. **If any of the requirements are not met, this will result in the ineligibility to receive a free Provisional Entry. No correspondence is possible with regards to this process or the outcome of this process.**
2. **Each eligible Participant may receive a maximum of one (1) free Provisional Entry through this free method of entry, keeping in mind that each individual may not hold more than one (1) Socios.com account or wallet.**
3. **The free Provisional Entry will be associated with the team indicated in the Participant's written request, and the free Provisional Entry will only be entered into the eventual prize draw if the selected team wins the 2026 World Championship final.**

Winners and Prizes

1. The prize draw is expected to take place on 24 July 2026, following the deadline for receipt and validation of any free postal entries. Winners will be selected by an independent third-party random number generator tool. Winners are expected to be announced following completion of the prize draw and winner validation.
2. The applicable and distributed prize pool will depend on the team that wins the 2026 World Championship final. No winners will be selected in relation to the losing team.
3. If Spain win:
 1. One (1) winner will receive one (1) signed Spain shirt; and

2. Three (3) winners will each receive one (1) unsigned Spain shirt.
 1. If Argentina win:
 1. One (1) winner will receive 1,000 \$ARG Fan Tokens; and
 2. Three (3) winners will each receive 500 \$ARG Fan Tokens.
 1. Only valid Provisional Entries associated with the Fan Token of the winning team will be entered into the prize draw.
 2. Four (4) winners will be selected at random from all valid prize draw entries that are eligible and corresponding to the winning team. The first selected winner will receive the applicable premium prize and the following three (3) selected winners will receive the applicable standard prizes. Multiple valid entries do not guarantee a prize.
 3. Winners are expected to be announced following the prize draw. The winners may be announced on the Socios.com platform or announced on or contacted through other channels as the Promoter deems fit.
 4. The prizes are non-exchangeable, non-transferable, and no cash alternative is offered, unless otherwise specified in the Campaign guidelines.
 5. Where necessary, it is the responsibility of the winner(s) to provide correct, up-to-date details upon acceptance of the prize. The data provided must be that of the winner(s) and never of third-parties. The Promoter cannot be held responsible for winner(s) failing to supply accurate information which affects prize acceptance or delivery of their prize.
 6. The Promoter reserves the right to withhold the prize, either in part or in its entirety, if the local regulations applicable to the winner prevent them from receiving the same due to regulatory, legal, or any other reasons associated therewith.
 7. Winner(s) must respond within 48 hours to the Promoter request to provide necessary details, including but not limited to wallet addresses and/or physical delivery information ("**Recipient Information**"), for receiving the prize.
 8. In the event that the winner(s) fail to provide the Recipient Information for delivery of the Prize within 48 hours from the Promoter's request, the Promoter reserves the right to draw an alternate winner under the same eligibility criteria and selection process. Any winner(s) who failed to provide the Recipient Information in this timeframe shall have no claims against the Promoter or any related entities for forfeiture of the prize.
 9. If the prize is being sent internationally or involves items subject to customs regulations, the winner(s) may be responsible for any applicable customs duties or taxes.
Furthermore, there may be jurisdictions where the Promoter is not able, at its discretion, to deliver/ship prizes.
 10. Any reward in relation to the Campaign shall be strictly limited to that described in these Terms, and any other rewards, prizes or benefits are hereby explicitly excluded.
 11. Participants acknowledge that the delivery of some prizes are entirely dependent on the successful delivery by a third party. Particularly (but not limited to), where a prize consists of a Spain shirt, delivery timing may vary due to stock availability, shipment and fulfilment timelines. The Promoter cannot guarantee delivery by a specific date. In the circumstance that the Promoter is unable to deliver a specified prize to a winner due to any type of impediment beyond the Promoter's control, the Promoter reserves the right, at its sole discretion, to substitute the prize with an alternative one. Alternatively, the Promoter may, at its discretion, choose not to award a substitute prize. The

determination of what constitutes such an impediment and the selection of an alternative prize (if any) will rest entirely with the Promoter. Participants acknowledge and accept this condition by participating in the Campaign.

Liability:

1. The Promoter accepts no responsibility whatsoever for entries not successfully completed due to a technical fault of any kind.
2. The Promoter shall not be held responsible for the non-fulfilment or partial fulfilment of any aspect of this Campaign in case the same is due to any third-party.
3. The Promoter will take reasonable measures to ensure the secure and timely shipping of physical prizes to the winner(s)' provided addresses. However, the Promoter may not be held responsible for any loss, damage, or non-delivery of the prize caused by factors beyond their control, such as postal or shipping services, customs procedures, or other unforeseen circumstances.
4. In case the physical prize is not deliverable due to factors beyond the Promoter's control, such as an incorrect address, the winner(s)' refusal to accept the package, or the winner(s) not being available at the delivery address, the Promoter may attempt to contact the winner(s) again to resolve the issue. If the prize remains undeliverable, the Promoter may reserve the right to disqualify the winner(s) or select an alternative winner.
5. **The Promoter, in its sole and absolute discretion, reserves the right to substitute the prize or a portion thereof with alternative prize(s) if circumstances arise beyond the control of the Promoter, rendering such substitution necessary. In the event that the delivery of the prize or a portion thereof becomes unduly difficult or impossible to execute, the Promoter shall not be held liable for any expenses or damages incurred by the Participants in connection with the prize. This provision encompasses instances of force majeure or other external circumstances beyond the control of the Promoter. Furthermore, if the local regulations applicable to the winner(s) prevent them from receiving the prize due to regulatory, legal, or any other reasons associated with token receipt, the Promoter reserves the right to withhold the prize, either in part or in its entirety.**
6. Any exclusion of liability of the Promoter in this section of the Terms shall automatically also refer to the exclusion of liability of the Promoter's affiliates and partners.

Breach of Terms & Consequences

1. Participants may not:
 1. Manipulate or attempt to manipulate the Campaign or any part thereof.
 2. Use multiple accounts or wallets to obtain an unfair advantage.
 3. Provide false or misleading information where required.
 4. Engage in fraudulent or abusive activity.
 5. Otherwise breach applicable laws, these Terms or the Socios.com Global Terms of Use.
1. Should a Participant be found in violation of these Terms at any point in time, whether during or after the duration of the Campaign, the Promoter, in its sole and absolute

discretion, reserves the right to take appropriate legal and corrective measures. Such measures may include, but are not limited to:

1. **Immediate Disqualification:** the Participant may be immediately disqualified from the Campaign or any other ongoing or future campaigns, contests, or promotional activities run by the Promoter.
2. **Legal Action:** the Promoter may pursue legal action against the Participant, seeking remedies, damages, or injunctions as deemed appropriate under applicable laws.
3. **Other actions:** the Promoter may take other actions it deems necessary to protect its interests.

Jurisdiction and Privacy

1. These Terms shall be governed by the laws of Malta. Any disputes arising out of or in connection with these Terms and/or the Campaign shall be exclusively referred to and finally resolved by the courts of Malta. The Participants of the Campaign expressly submit to the exclusive jurisdiction of these courts.
2. Any personal data supplied during the course of this Campaign may be passed on to third-party suppliers only insofar as required for the fulfilment of the Campaign and delivery of the prize. The handling of personal data by the Promoter shall be strictly related to the selection of the winners and the prize delivery and in accordance with the Promoter's privacy policy available at <https://www.socios.com/legal-hub/policies/privacy/privacy-policy/en>.
3. Personal data will be used as necessary to administer the Campaign, verify eligibility, conduct the prize draw, contact winners and fulfil prizes, unless otherwise permitted by law.

General Provisions

1. The decision of the Promoter regarding any aspect of the Campaign and the prize is final and binding, and no correspondence will be entered into about it.
2. Participants are deemed to have accepted and agreed to be bound by these Terms upon entry into the Campaign. The Promoter reserves, at its sole and absolute discretion, the right to, at any time, refuse entry, disqualify, or refuse participation to anyone in breach of these Terms and/or any applicable law.
3. If a Participant uses fraudulent methods or otherwise attempts to circumvent these Terms, such Participant shall be discarded at the sole discretion of the Promoter.
4. The Promoter reserves the right to hold void, cancel, suspend, or amend the Campaign, or any part thereof, at any time at its own discretion.
5. Insofar as is permitted by law, the Promoter, its agents or distributors will not in any circumstances be responsible or liable to compensate the Participants or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the gross negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.

6. The Promoter reserves the right, at its sole discretion, to change, modify, add to, or remove portions of these Terms at any time without prior notice. Changes will be effective when posted on the Campaign platform or website, and it is the Participant's responsibility to review these Terms periodically for updates. Your continued participation in the Campaign following the posting of changes will mean that you accept and agree to such changes.
7. By entering in the Campaign, Participants accept and agree to participate in publicity material related to the prize and this Campaign only, which may include the publication of the Winner's name and images in any media (including social media) of the Promoter and any of the Promoter's affiliates. The winner(s)/Participants may be requested to participate in promotional filming of the Campaign during the prize experience. Such filmed content may be used by the Promoter and its affiliates. All rights, including image and property rights, arising from the creation of any film material or content shall remain the sole property of the promoter and its affiliates.
